Methylchloroisothiazolinone	26172-55-4	Preservative	None	a substance that prevents or retards microbial growth or chemical degradation of other ingredients and thus protects finished products from spoilage. The use of more than one preservative can sometimes increase efficacy due to synergism.
Methylisothiazolinone	2682-20-4	Preservative	None	a substance that prevents or retards microbial growth or chemical degradation of other ingredients and thus protects finished products from spoilage. The use of more than one preservative can sometimes increase efficacy due to synergism.
